**PRESCHOOL TUITION**

<b>Three Days</b>	\$370.00 monthly
<b>Four Days</b>	\$464.00 monthly
<b>Five Days</b>	\$549.00 monthly
<b>Registration Fee</b>	\$100.00 per child

**Admission**

Admission to SVS preschool is available to children ages 3 (by Aug. 1) through 5 years of age. All children must be independent of the bathroom or in other words "potty-trained". " **NOTE: children who turn 3 years old between August 1st and January 1st may start preschool on January 1<sup>st</sup>.**  
A waiting list will be maintained.

Admission will be accepted using the following criteria:

- 1<sup>st</sup>) Re-admittance for current preschoolers (Example: Current 3 year old returning as a 4 year old)
- 2<sup>nd</sup>) Sibling of current St. Vincent student
- 3<sup>rd</sup>) From St. Vincent, Immaculate Conception, or Immaculate Heart of Mary Parishes (referred to as "Our 3 Parishes") and planning on sending student onto St. Vincent de Paul School for Kindergarten through 8th grade.
- 4<sup>th</sup>) Not from Our 3 Parishes and planning on sending student onto SVS for K through 8th grade.
- 5<sup>th</sup>) From Our 3 Parishes and not planning on sending student onto SVS for K through 8th grade.
- 6<sup>th</sup>) Not from Our 3 Parishes and not planning on sending student onto SVS for K through 8th grade.

The waiting list date will be used when 2 students have the same criteria within each of the above numbered categories.

New students will be notified of placement at St. Vincent Preschool by May 6, 2022.

For any changes made to the original enrollment agreement, a \$100.00 fee will be assessed and changes can only occur if another student can fill the spot that was changed.

**Payment**

**A.** The registration fee is due with the completed registration form and should be returned to the school office by **March 11, 2022** for families of returning preschool students and as soon as possible for families of all new students. Registration fees are non-refundable.

**B.** Tuition payments are to be paid the first of each month. The month of August will be 50%; September thru May will be full payments. The final monthly payment must be made before the end of the school year. Tuition and fees are to be current for students to be admitted to classes in the second semester (early January).

**C.** Due to staffing requirements, fees are applied throughout the school year regardless of absences, sick days, snow days, etc.

**Before School Supervision:** Supervision starts at 6:45 am.

**FAST Program (Fun After School Time):** 3:30 pm to 6:00 pm

**Annual Registration Fee:** \$25.00 per family

**Daily Rates:** One Child = \$7.00 Two or More Children = \$12.00

**Hot Lunch Program:**

- 5 full day program - \$78.00 per month
- 4 full day program - \$62.00 per month
- 3 full day program - \$47.00 per month
- No refunds for absences or vacations, etc.

Free or reduced price lunches are served daily to those who qualify. Each family will receive the guidelines and application from the State of Missouri at the beginning of school.

Should Breakfasts resume after the Covid virus: Proceeds from the first Sunday breakfast help to offset the cost of the school hot lunch program therefore, if your child attends SVS on a full-time basis (4 or 5 days a week) both parents are required to work a First Sunday Breakfast during the school year (June to May). If your child attends on a part-time basis (3 days a week), one parent is required to work a breakfast.
